I THOMAS BOXALL of Aldershott in the County of Southampton yeoman being in good & perfect mind & memory (God be praised) doe hereby make & declare this my last will & testament in manner & forme followeinge

And first I bequeath my soule to Almighty God my creator hopeing to bee saved by the death & passion of Jesus Christ his only sonne my Saviour & Redeemer And my body I committ to the earth to be buryed in decent manner

And for my worldy estate I devise the same as followeth

And ffirst I give & bequeath to my well beloved wife SARAH All those my ffreehold lands tenements & hereditaments with the appurtenances called Woodlands or by any other name or names conteyning by estimation thirty Acres bee the same more or lesse nowe in my owne occupation lying & being in Badshott in the parish of ffarneham in the County of Surr'shire which I late purchased of WILLIAM WHEELER. To have and to hold to her the said SARAH my said wife for & dureing the tearme of her naturall life

And from & after her decease I give & bequeath the said ffreehold lands to my eldest sonne JOHN BOXALL To have & to hold to him the said JOHN BOXALL his heires & assignes forever subject nevertheless to the provisoe or condition hereafter mentioned (that is to say) provided alwayes and it is my desire and I doe hereby will direct & appoynt That THOMAS BOXALL my younger sonne & his heires shall forever have hold & enjoy all that my coppyhold messuage Barne garden orchard & lands with the appurtenances lying in the parish of ffarneham aforesaid & nowe or late in the occupation of EDWARD HEDGER & GEORGE LAMPARD or their assignes and lately purchased by mee of Mr JOHN SAYELL & his wife or one of them

And alsoe that hee the said THOMAS BOXALL my younger sonne & his heires shall forever hold & enjoy all such Coppyhold lands tenements [] lyeing in Aldershott aforesaid as I either already have or shall att any tyme dureing my life surrender to the wife of the said THOMAS BOXALL & his heires And that without any lett interruption or contradiction of or by my said eldest sonne JOHN BOXALL or his heires

And therefore I doe hereby order & appoynte [deleted] that the said JOHN BOXALL my said eldest sonne & his heires shall forever after my decease permit & suffer the said THOMAS BOXALL my said younger sonne & his heires to hold & enjoy all & every the said coppihold messuages lands tenements & hereditaments

And that hee the said JOHN BOXALL & his heires soe soone as hee or they attaine to the age of One & Twenty yeares uppon the request costs & charges of the said THOMAS BOXALL or his heires shall well & sufficiently surrender & covey all & singular the said coppihold [deleted] messuages lands tenements & hereditaments to the said THOMAS BOXALL my said sonne & his heires freed of all incumbrance done by him or them And in case hee the said JOHN BOXALL & his heires shall in any manner disturbe the said THOMAS BOXALL my said younger sonne in the enjoyment of the said Coppihold Messuages lands & premises or any parte thereof

Or if the said JOHN BOXALL or his heires [doe or shall refuse or neglecte] soe soone as hee or they attayne to the age aforesaid doe or shall refuse or neglect to make such surrender or surrenders as aforesaid That then & from thenceforth in both or either of the said cases I doe hereby will give & devise all & singuler the said ffreehold lands tenements & hereditaments with the appurtenances called Woodlands (devised to my said sonne JOHN BOXALL as aforesaid) to

him the said THOMAS BOXALL my said younger sonne

To have & to hold to him the said THOMAS BOXALL his heires & assignes forever Anything in this my will conteyned to the contrary thereof in any wife notwithstanding Item I doe hereby further give & devise to the said THOMAS BOXALL my said sonne All that my parcell of meadowe ground with the appurtenances called Preymead or by any other name conteyninge by estimation [ffower] Acres bee the same more or lesse lyeing in Badshott aforesaid in the said [parish] of ffarneham & nowe in my owne occupation & heretofore purchased by my late father dec'd of WILLIAM BOXALL

To have and to hold The said parcell of meadowe ground with the appurtenances to the said THOMAS BOXALL my said sonne his heires & assignes forever Item

I doe hereby give & devise to JOHN DARE & SUSAIN DARE the sonne & daughter of THOMAS DARE ffifty shillinges apeice

And I give & bequeath to the Church of Aldershott Tenn shillinges

And I doe hereby nominate constitute ordayne & appoynte my said sonnes JOHN BOXALL & THOMAS BOXALL Executors of this my last will & testament to whome after my debts & legacies paid & my funerall expences discharged I give & bequeath all the rest residue & remainder of my goods chattells & personall estate whatsoever

In Witness whereof to this my last will & testament conteyninge twoe sheetes of paper I have to each sheete sett my hand & to both of them affixed my seale the day & yeare ffirst above written
